Terms and Conditions

An agreement made on

day of

between Corrib Oil Ltd. whose registered office is, Tuam Road, Galway (hereinafter in this Agreement called the Seller) of the one part and (hereinafter in this Agreement called the User) of the other part.

It is hereby agreed as follows:

- The Agreement shall commence on the date of execution hereof.
- 2. The Seller will issue to the User Corrib Oil Fuel Cards to enable the user to obtain for use by road vehicles, from specified Corrib Oil Ltd. sites in the Republic of Ireland as are a party to the Corrib Oil Card system and displaying the relevant sign, supplies of the Seller's brands of Motor Spirit, Derv and Lubricating Oil only upon the terms and conditions as set out in this Agreement.
- 3. The price for the supply of any product or service against production of a Corrib Oil Fuel Card shall be that notified at the time of supply by the Corrib Oil Ltd site.
- 4. The Seller's cards are issued as a service to purchasers of those products made available by this agreement, and possession of a Corrib Oil Fuel Card shall not confer any right or entitlement upon the user to receive such products either from the Seller or its associated companies participating in the Corrib Oil Fuel Card service scheme or from any Corrib Oil Ltd site.
- 5. The Seller or its associated companies shall not be liable for any injury occasioned upon the User or any of its employees or Agents or any loss or damage suffered by the User which shall arise from any act, default, omission or negligence on the part of any Corrib Oil Ltd site or its servant or Licensees or any part of the Sellers associated companies, their servants, agents or Licensees.
- 6. Corrib Oil Fuel Cards shall at all times remain the property of the Seller who may terminate this agreement and cancel the Corrib Oil Fuel Cards or refuse to renew them at any time. On cancellation, cards shall be surrendered forthwith and any Corrib Oil Ltd site to whom a cancelled Corrib Oil Card is presented shall be entitled to retain it and return it to the Seller. The termination of this Agreement and cancellation of the Cards shall not affect any liabilities of the User incurred prior to termination.
- 7. The Seller shall be entitled to terminate this Agreement forthwith in the event of the User exceeding the agreed credit limit or in the event of fraudulent use or in the event of a breach of Clause 12; and the User shall indemnify the Seller where the cards continue to be used after termination.
- The User agrees that the Corrib Oil Fuel Card will be issued to him only for use in connection with that vehicle whose registration number is shown on its particular Corrib Oil Fuel Card and that any product purchased with the Corrib Oil Fuel Card will be consumed by that vehicle and will not be sold or otherwise disposed of.
- 9. The User will exercise every possible care to prevent Corrib Oil Fuel Cards being lost or stolen and will forthwith notify any loss or theft to Corrib Oil Ltd,. The user undertakes to notify immediately the Seller in the event of the disposal by him of a vehicle whose registration number is shown on a particular Corrib Oil Fuel Card and to immediately return to Corrib Oil Ltd the card for cancellation. Replacement cards will incur a €10 charge.
- 10. The User undertakes to indemnify the Seller and its Associated companies from all losses, claims, expenses and costs which the Seller or its Associated companies may sustain or incur by reason of a Corrib Oil Fuel Card being used for a purpose other than one permitted by the terms of this agreement, or being used by any person not authorised by the User, or by reason of any negligent or dishonest conduct relating to the use of Corrib Oil Fuel Card. The User agrees that for the purposes of making good any losses the Seller may, inter alia, debit the user's account with an amount equal to the cost of any product or I

- services supplied as a result of any Corrib Oil Fuel Card issued to him in pursuance of this Agreement being used other than in accordance with this Agreement.
- cards shall be charged by the Seller to the User's account in the following manner and a statement of amount so charged shall be sent to the User as set out hereunder:

 (i) Summary invoices shall be issued monthly by the Seller to the User, (ii) The summary invoices will list purchases and location of purchases, (iii) Payment shall be made on the 20th day following date of statement by Direct Debit (iv) Should the user fail for any reason to meet the Direct Debit mentioned in this clause, then without prejudice to any rights of the Seller hereunder, interest at the rate of 2.5% per month will automatically be charged on the amount stated as owing by the

Seller until such stage as the monies owing have been repaid in

- 12. The User agrees not to attempt to use a Corrib Oil Fuel Card to obtain any product or service other than from a Seller appointed Agent authorised to issue product on foot of such a card. The User further agrees not to attempt, by presentation of a Corrib Oil Fuel Card, to obtain from the Seller's appointed Agents cash or products or services other than those specified in this Agreement.
- 13. This Agreement is personal to the User and shall not be assigned in whole or in part by the User under any circumstances whatsoever.
- 14. The User shall be responsible for all duties and taxes arising on the issue to and use of the Corrib Oil Fuel Card by him.
- These conditions shall apply once the cards are issued to the User
- 16. The Seller may amend these conditions at any time by giving notice of variation. Publication of the variations by such means that the Seller may decide shall constitute effective notice to the User.
- 17. PIN- The principal card holder and the Authorised card holder shall use the PIN if so required by an outlet. The PIN shall only be used by the principal card holder and Authorised card holder to whom it is supplied and shall not be disclosed directly or indirectly to another person. The PIN shall not be written on any card or sales voucher or on anything kept with the card.
- 18. Cancellation of cards- The Seller will cancel a card if the principal card holder requests cancellation in writing and encloses the relevant Card cut in half. The Seller may request the return of all/any cards or cancel or suspend all/any cards at any time without notice or refuse to reissue, replace or renew any card. A request for return or a cancellation or suspension is without prejudice to the principal card holder's liability in respect of use of any cards prior to the actual return of the relevant card to the Seller.
- 19. If a card is lost or stolen or remains in the possession of a person who has ceased to be an authorised card holder the principal cardholder must immediately notify the Seller of the loss or theft or unauthorised use of the card, and also notify the police and obtain a crime reference or lost property reference number. If notification of loss, theft or unauthorised use of a card is given verbally it must be confirmed by the User in writing within 3 days. It is the responsibility of the principal card holder to ensure that no card remains in the possession of any person who has ceased to be an authorised card holder.
- 20. The Seller shall have no liability or obligation to the Principal card holder to comply with the terms of this Agreement due to circumstances that are beyond the reasonable control of the Seller, its agents or contractors.
- 21. This agreement shall be governed by and construed in accordance with the laws of Ireland and the parties hereby irrevocably submit to the non-exclusive jurisdiction of its courts.
